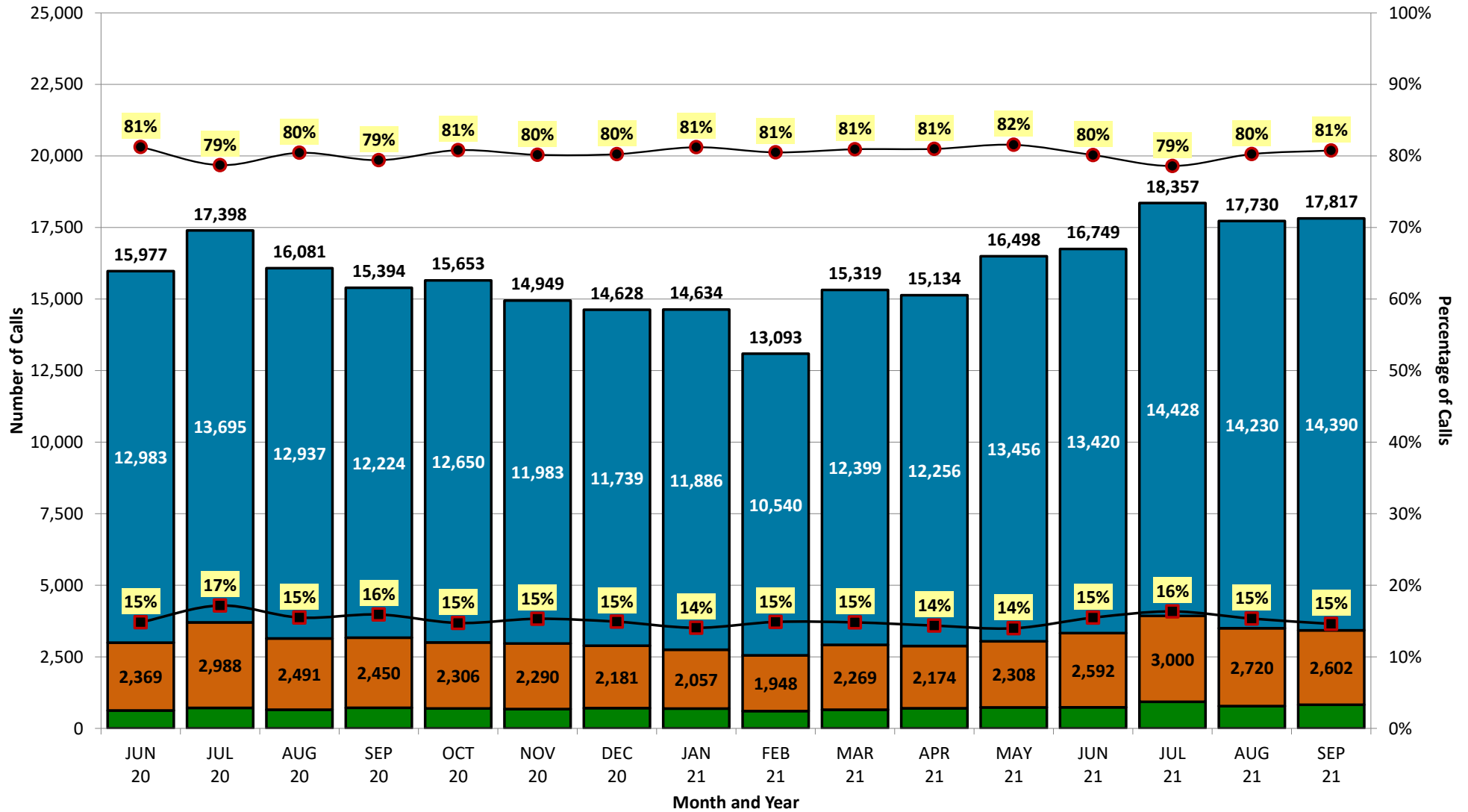

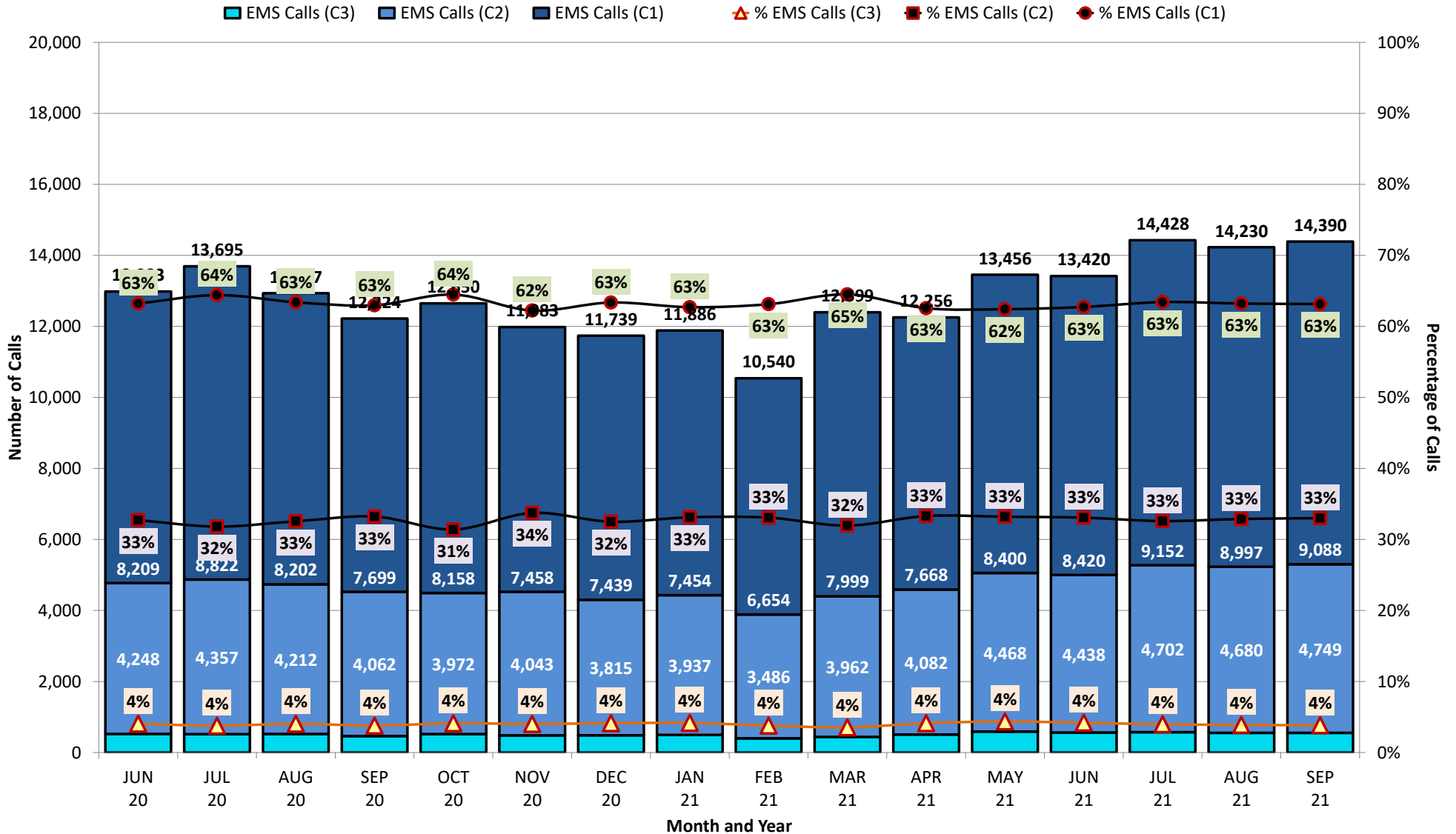
Call Volume: **EMS (G1), Fire (G2), Other (G3)** With Percentages of Calls (EMS and Fire)

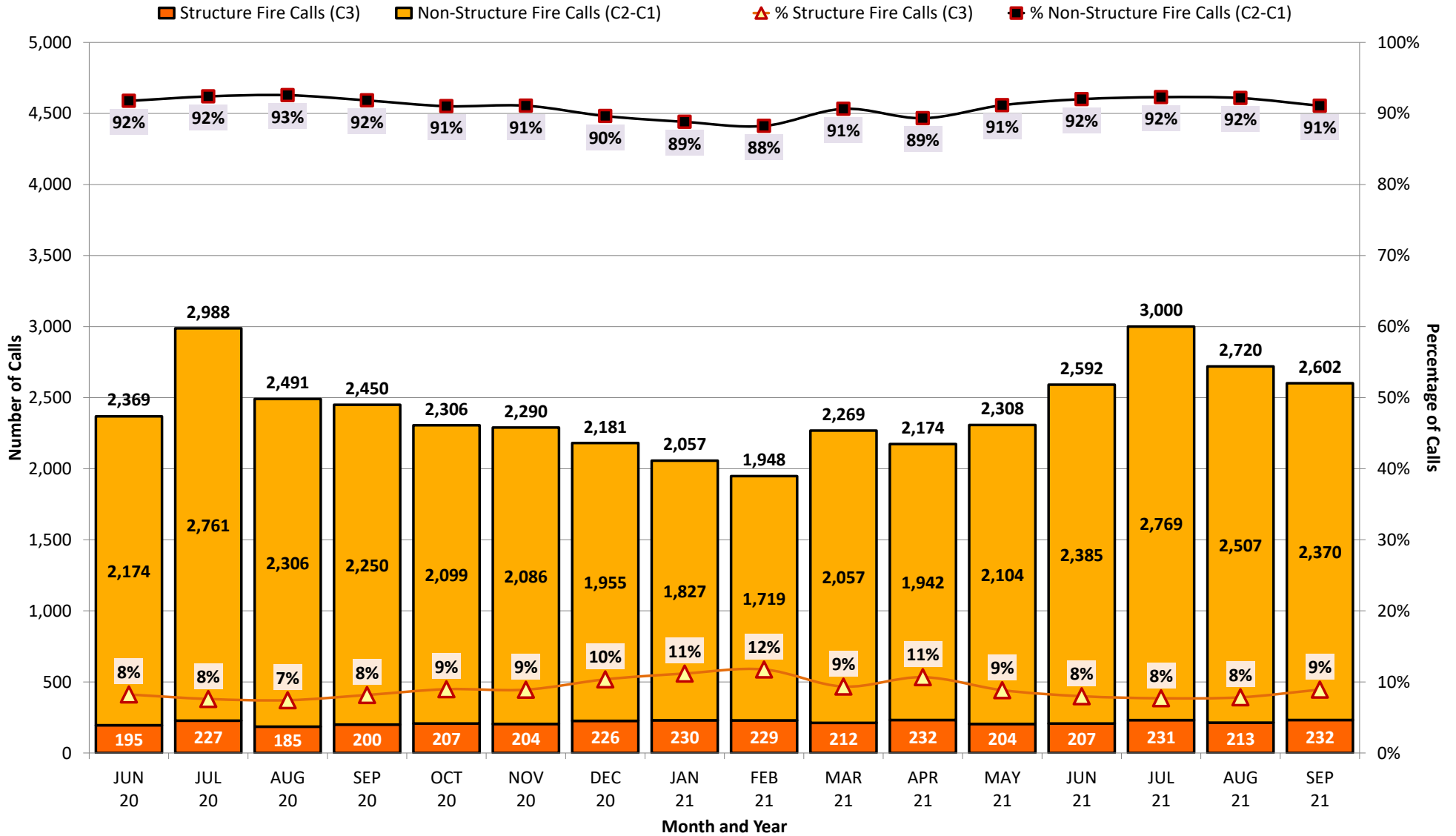

Call Volume: **EMS (G1) by Priority** With Percentages of Calls (C3= Highest, C2= Higher, C1= Lower)



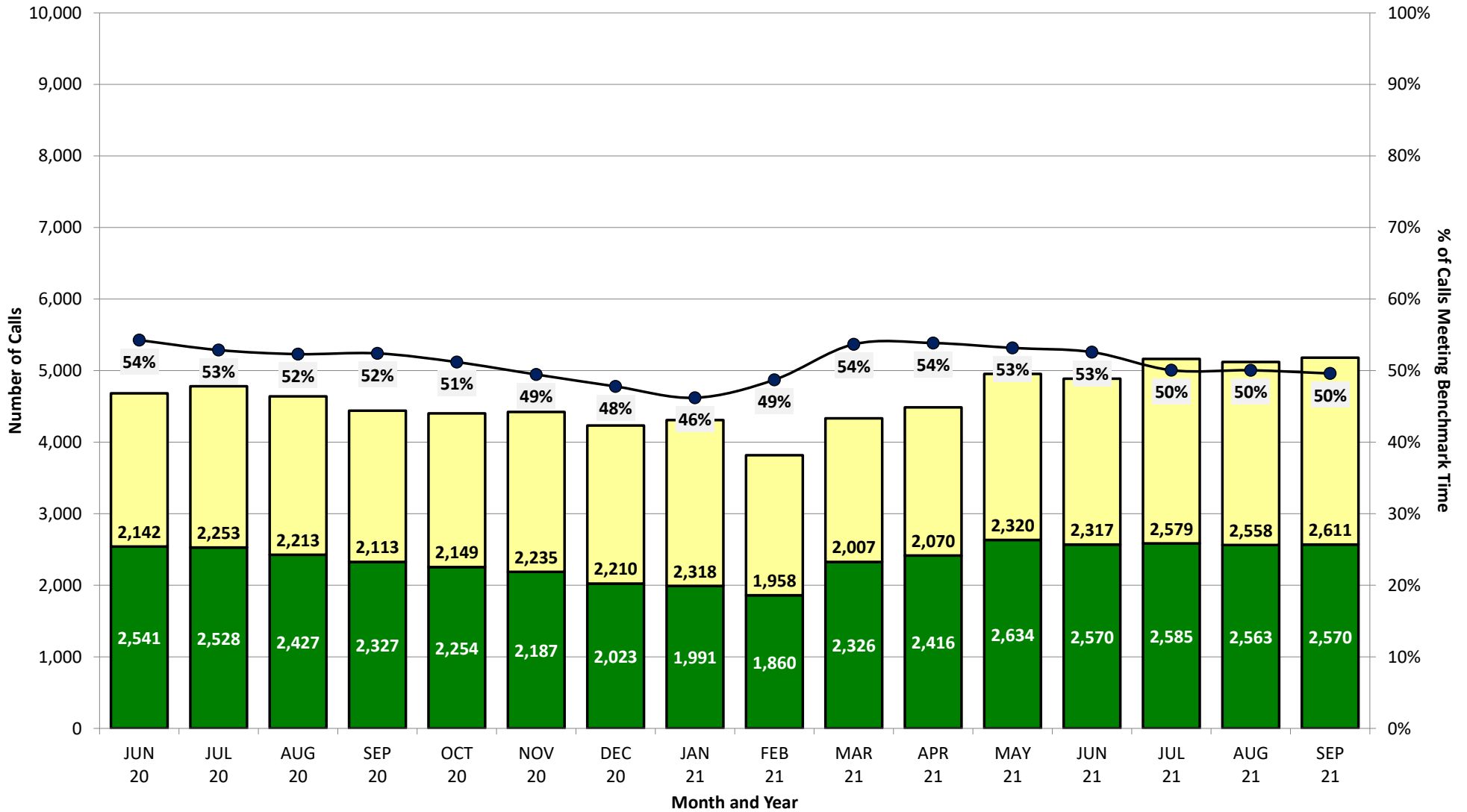

Call Volume: **Fire (G2) by Priority** With Percentages of Calls (C3= Structure Fire, C2-C1= Non-Structure Fire)



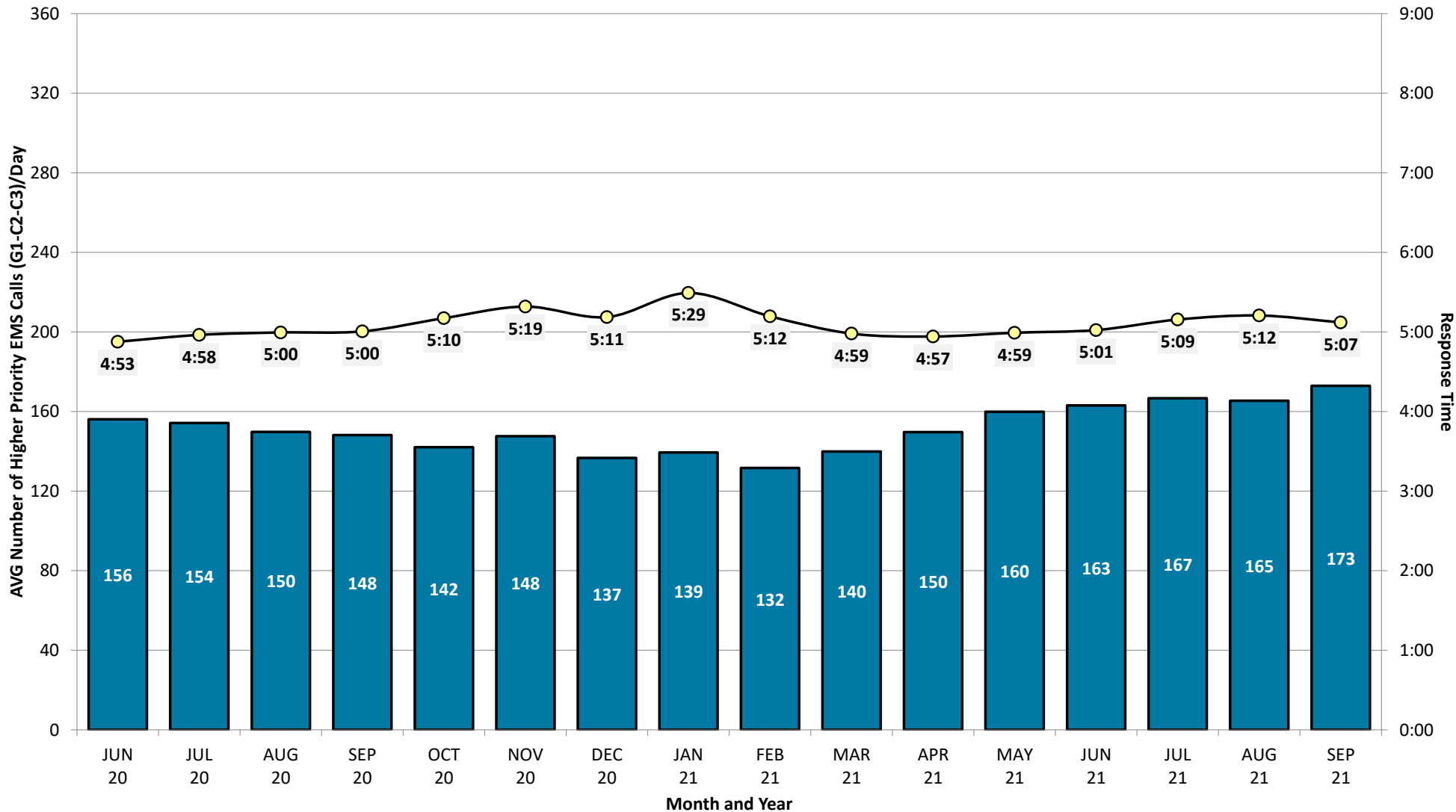

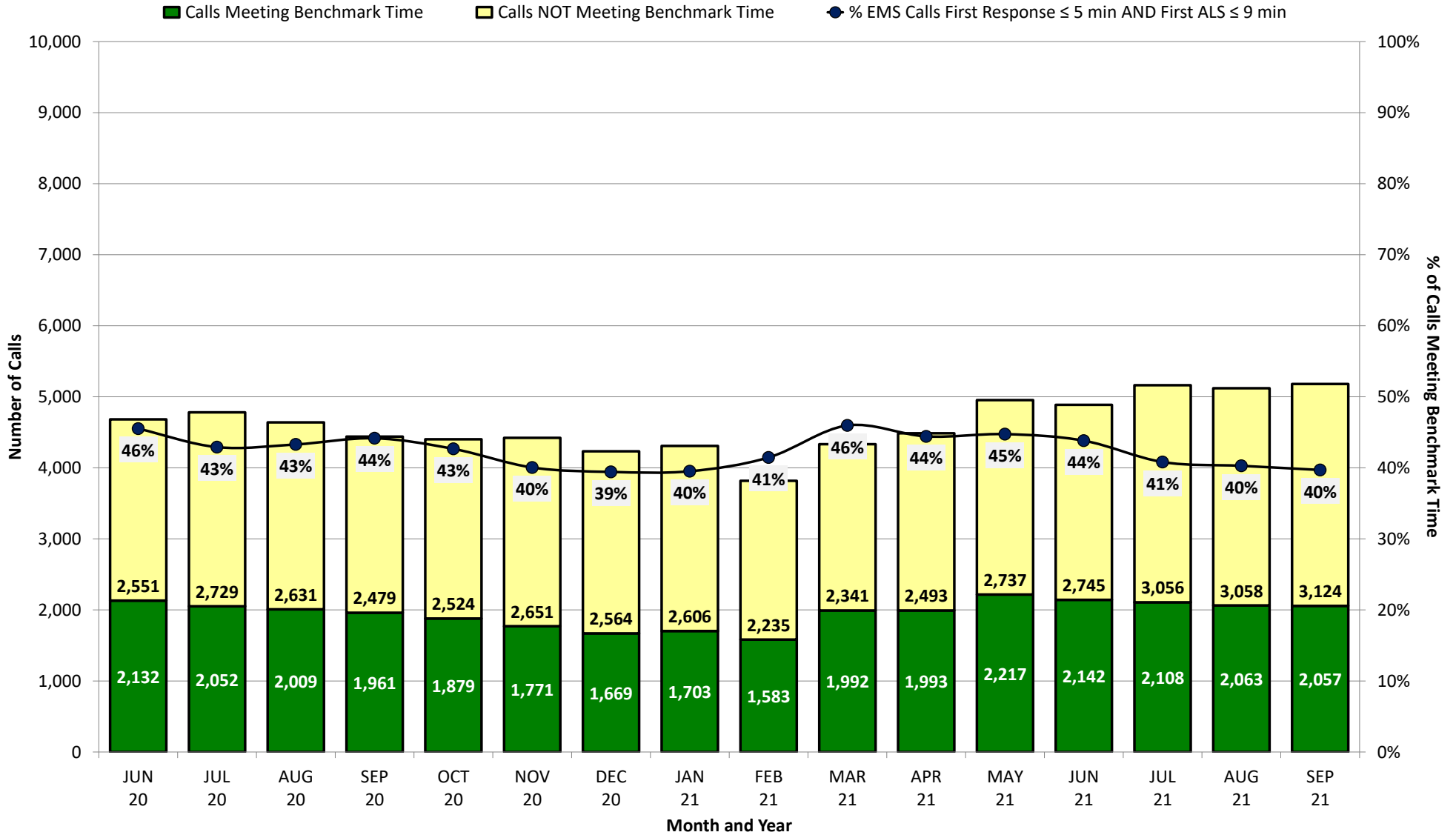

■ Average Daily Call Count ● Average Response Time EMS Calls

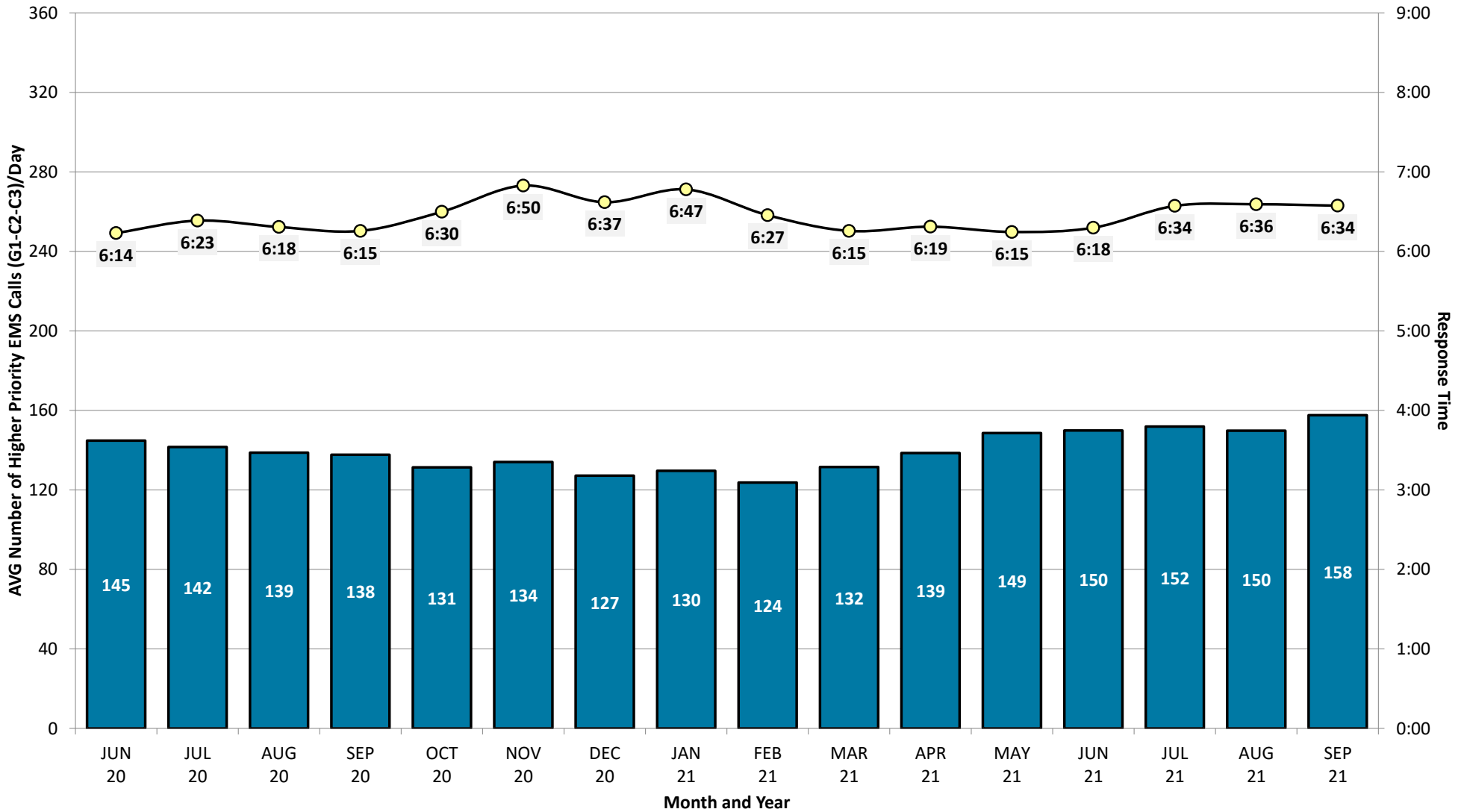

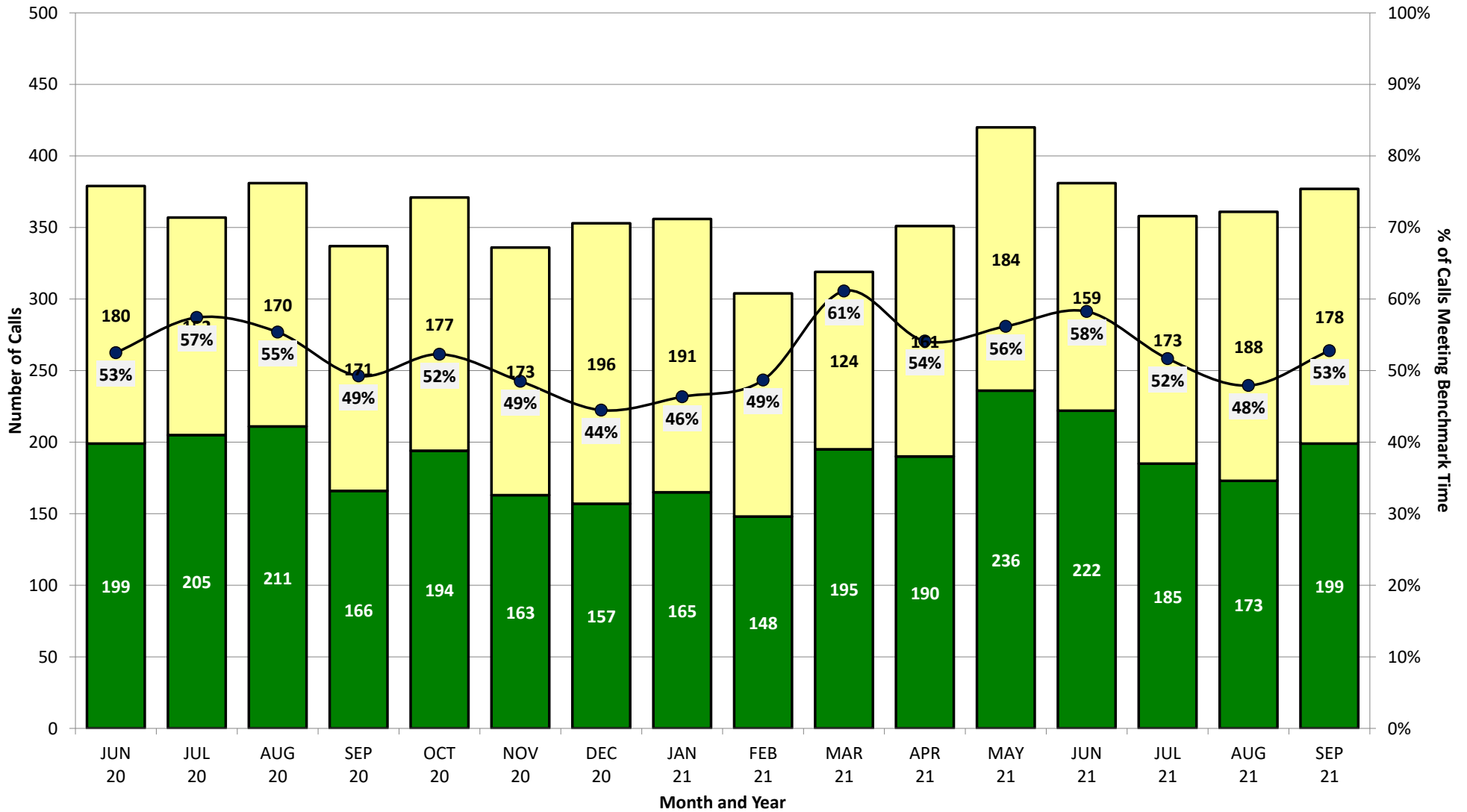

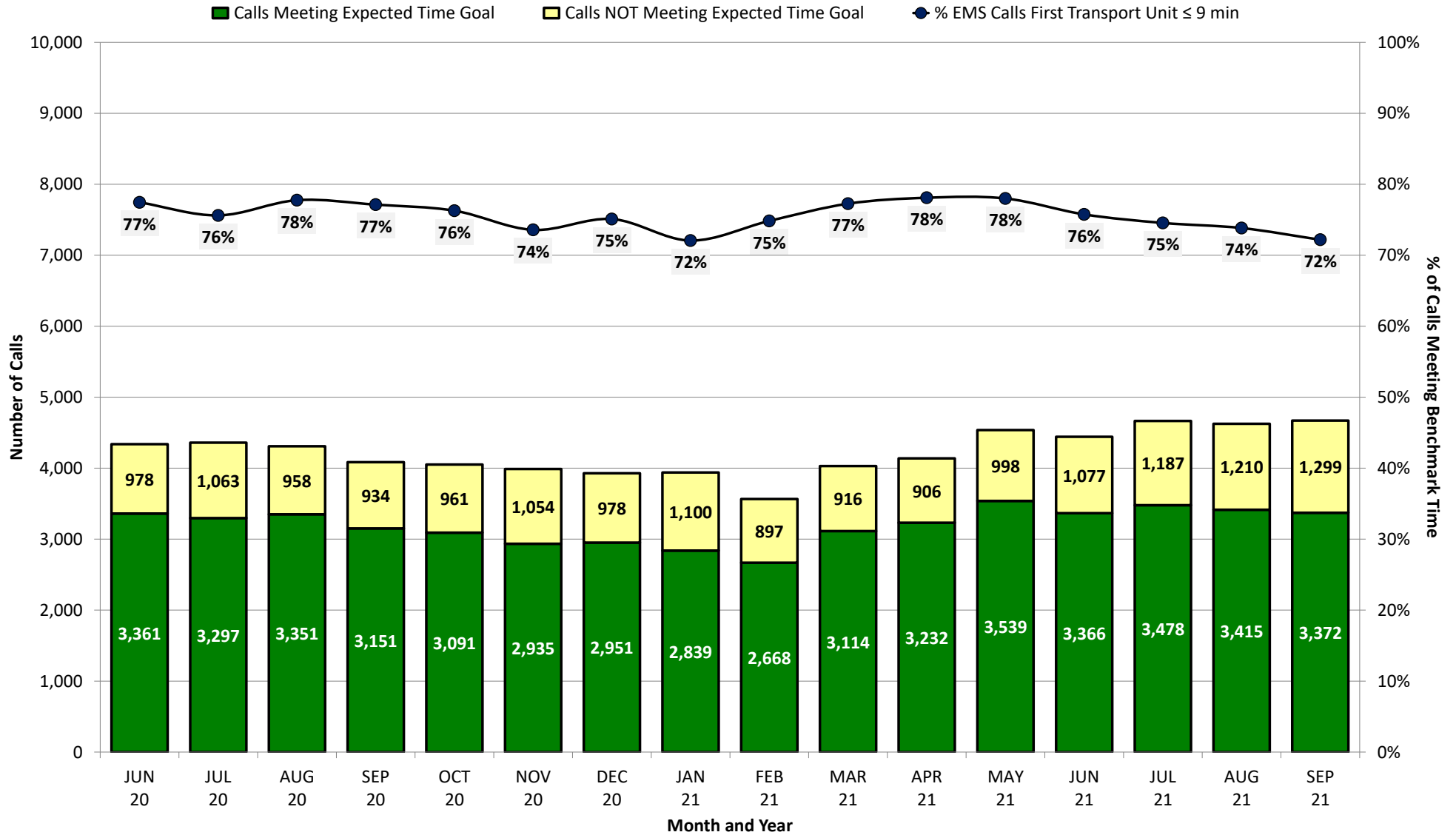

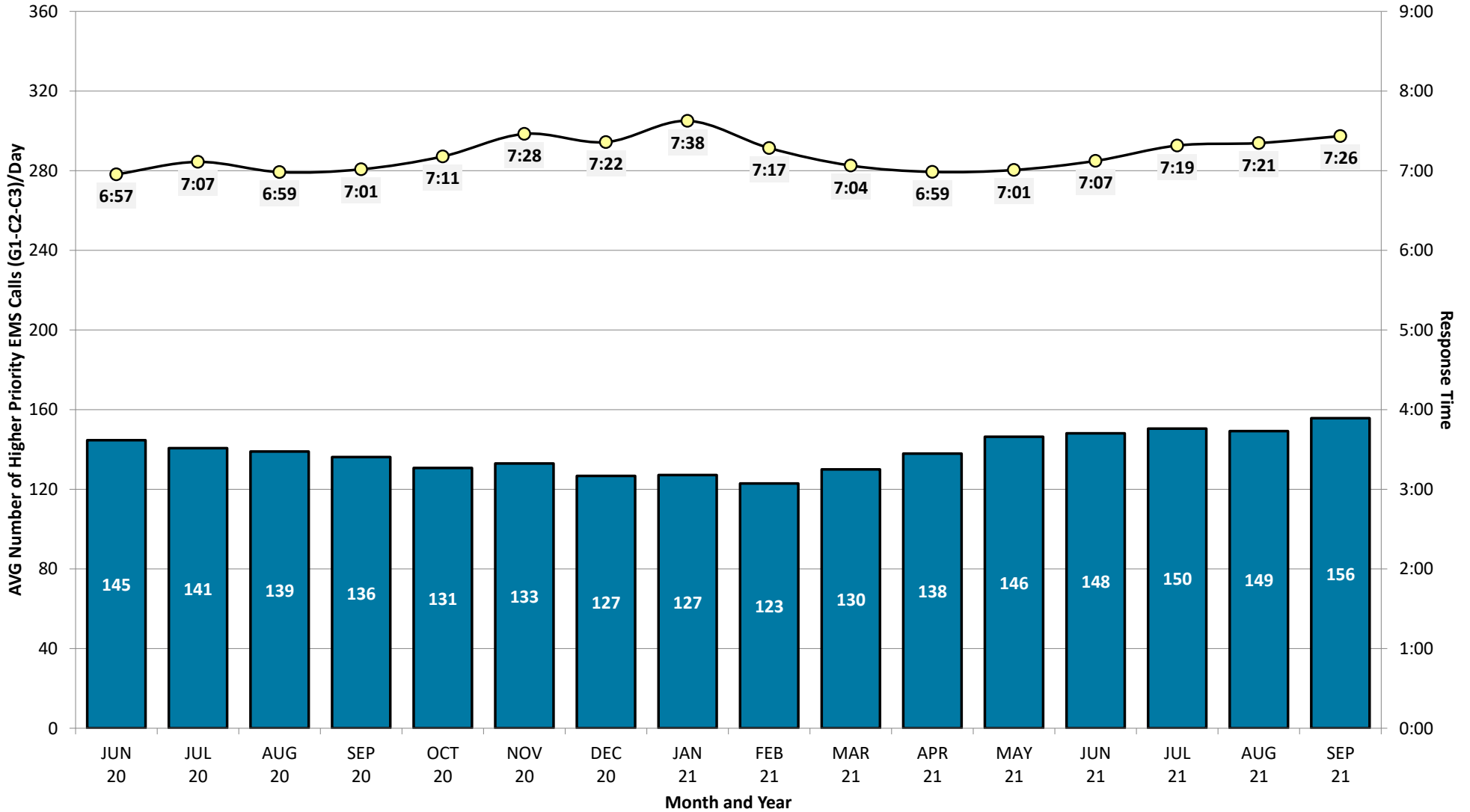

FEMS: EMS Response ≤ 9 Min (G1-C2-C3 Calls) First Transport Unit (Ambulance or Medic Unit)



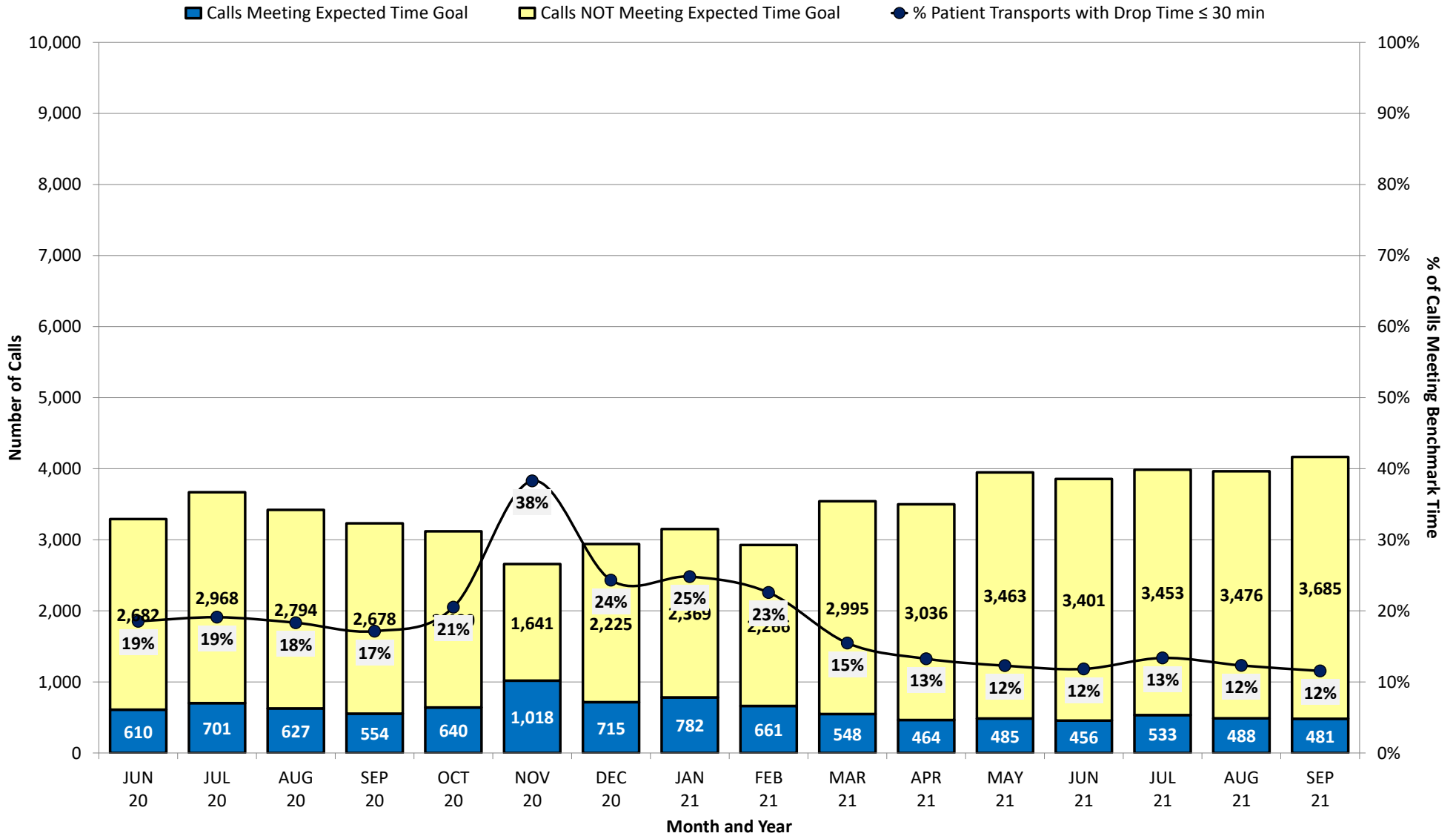

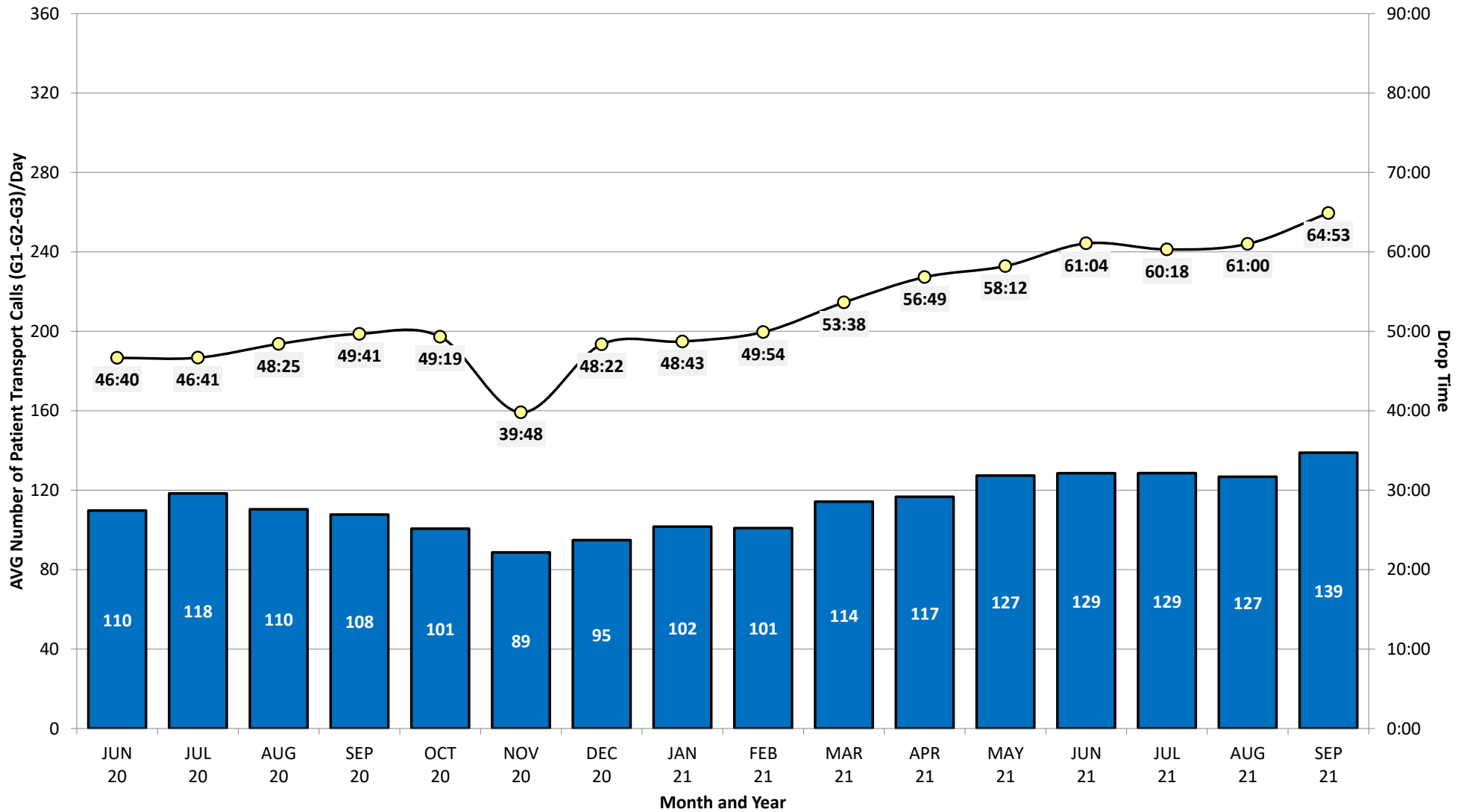

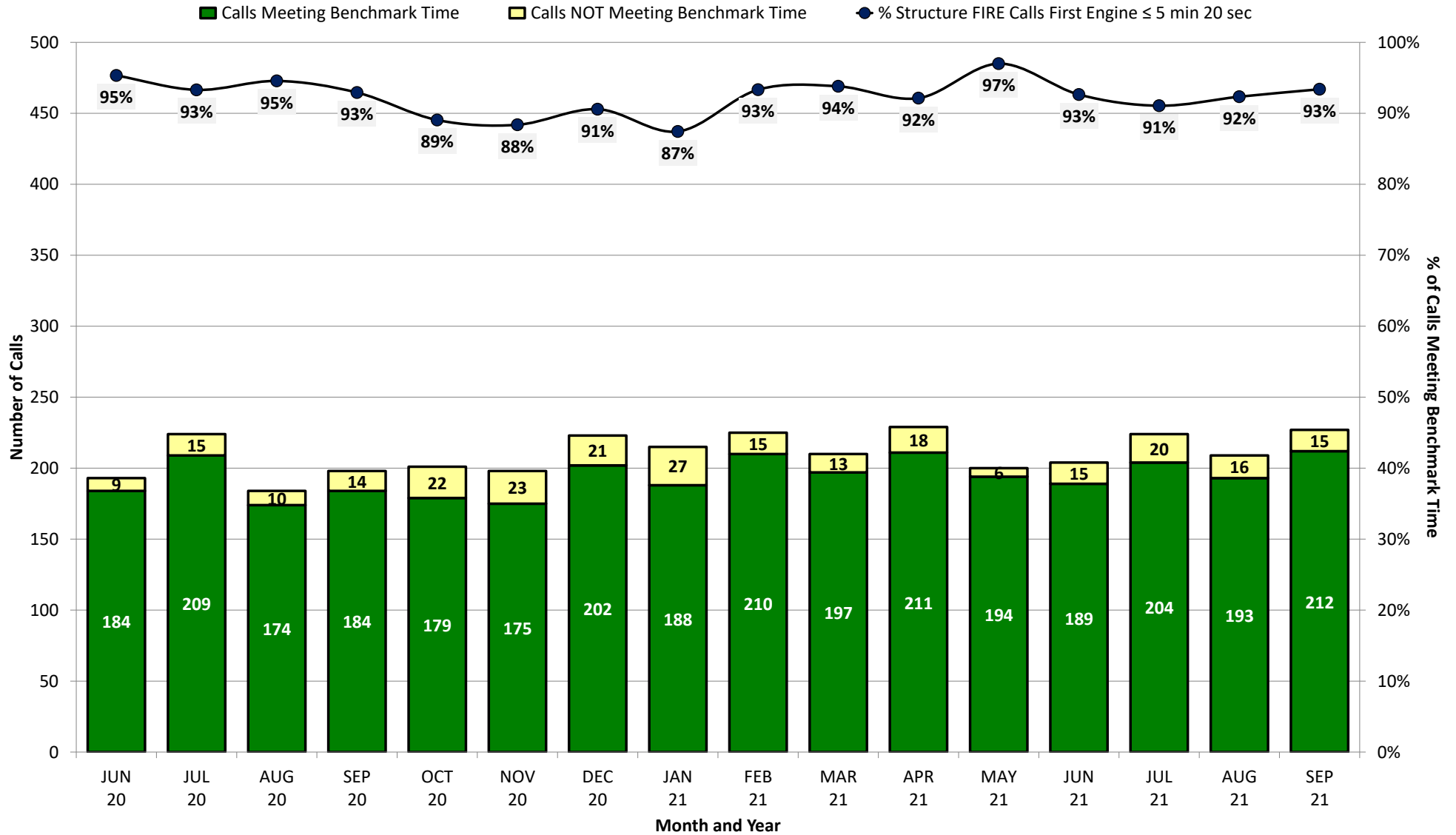

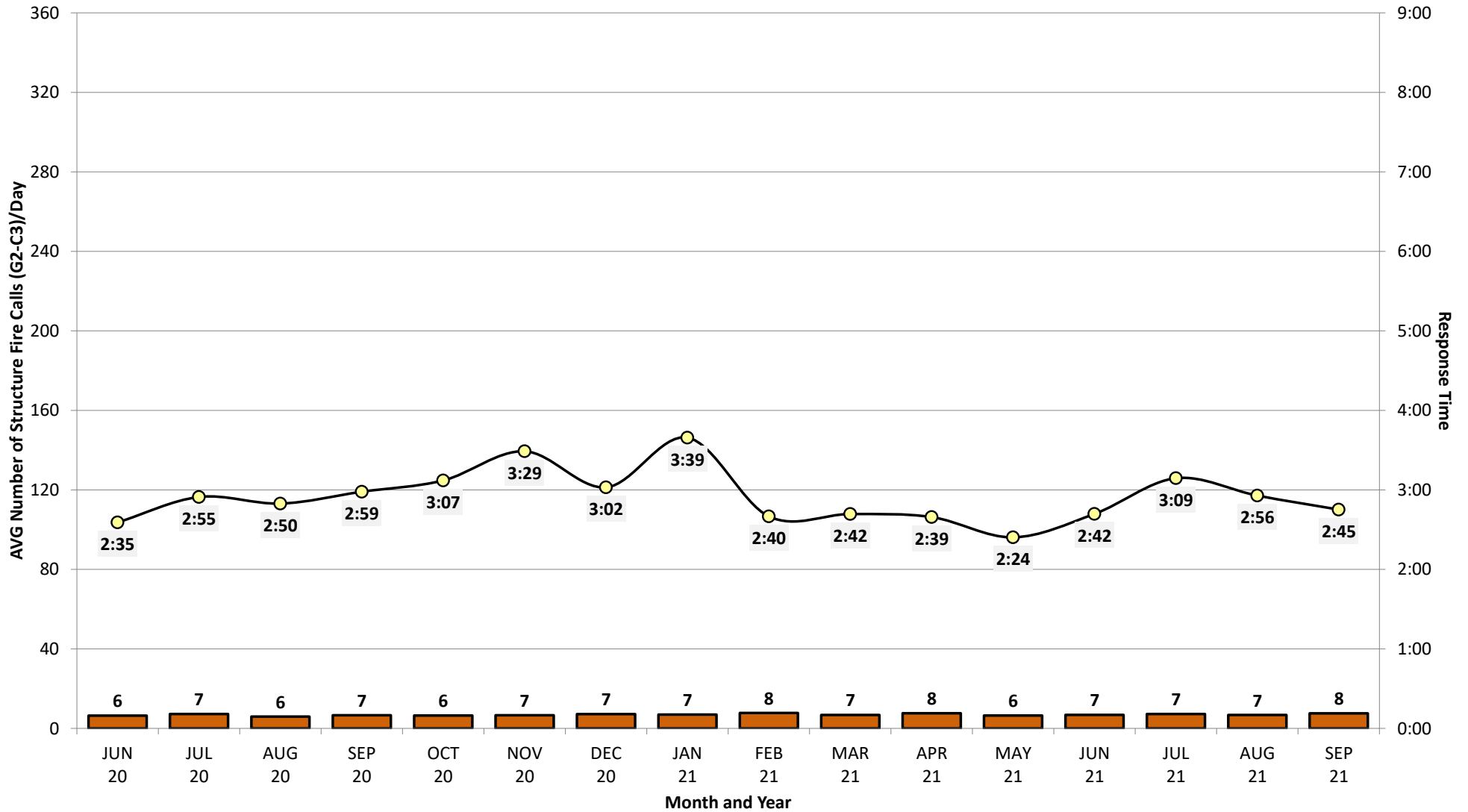

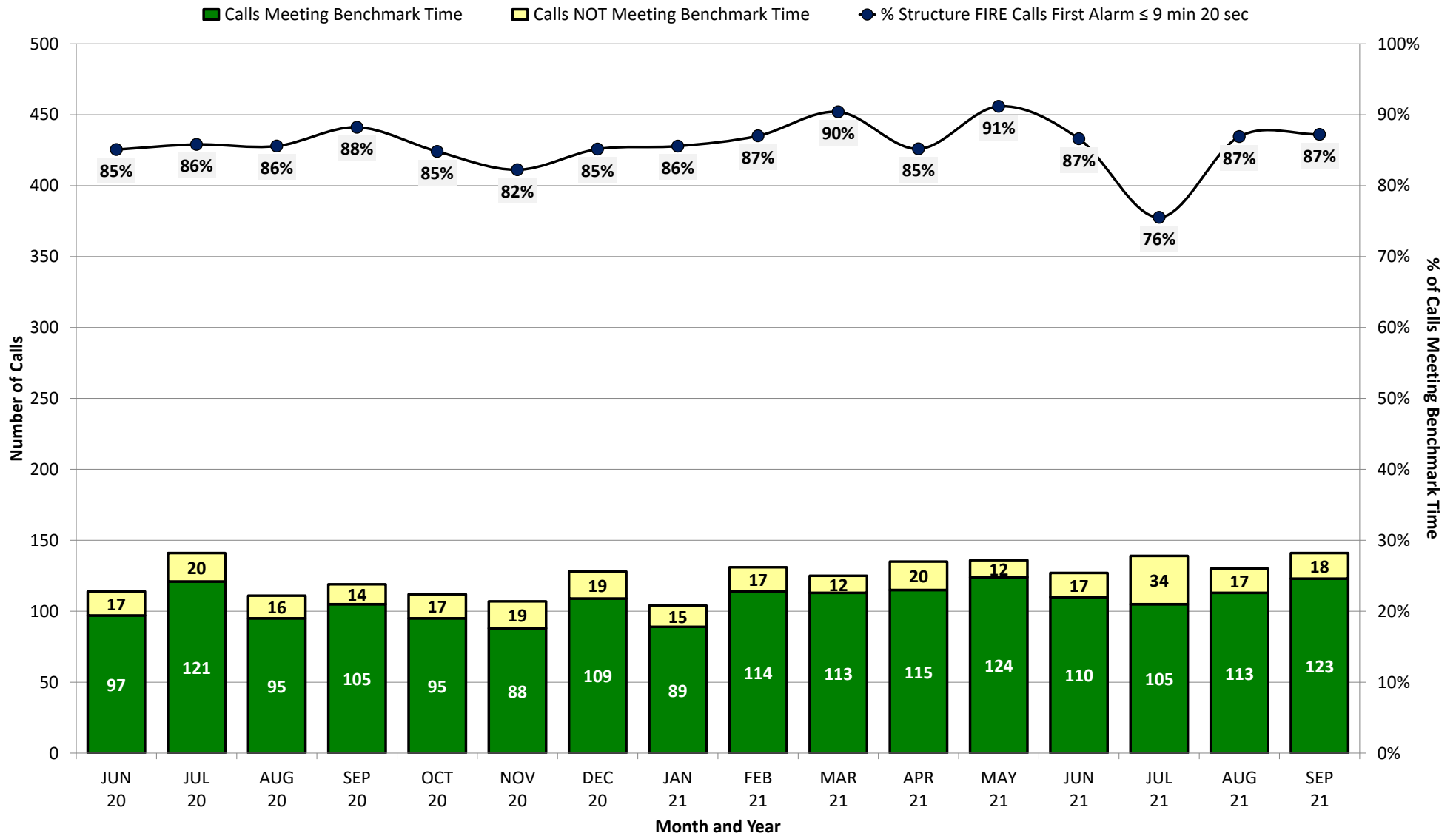
